Reinforcing the master and doctoral programs taught in foreign languages

Minimum standard: 6 programs / term of office

Achieved: 15 master programs

In the current academic year, 15 master programs taught in foreign languages are running, as follows:

- 6 programs within the Faculty of Business Administration in foreign languages: Entrepreneurship and Business Administration (in English, French and German), Business Administration in English, Entrepreneurship and business administration in energy (in English), Romanian German MBA on Entrepreneurial Management (in German);
- 3 programs within the Faculty of International Business and Economics: The Management of International Business (in English), English Language Education and Research Communication for Business and Economics;
- 2 programs at the Faculty of Accounting and Management Information Systems: Business Accounting (in English), Accounting, auditing and IT Management (in English);
- 1 program at the Faculty of Economic Cybernetics, Statistics and Informatics: Computer Security (in English);
- 3 programs in Bucharest Business School: Romanian-French MBA INDE, Romanian-French MBA INDE hybrid, Romanian-Canadian MBA (in English).

We will start the process of accreditation / reaccreditation of the international study programs. Currently, the Romanian-Canadian MBA program is in a process of restructuring and consolidation, following the change of partnerhip (Université du Québec à Montréal).

Also in the process of preparing for the external evaluation of the quality of education an important step is the participation in the second U-Multirank evaluation, ranking conducted under the coordination of the European Commission. The 2016/2017 edition will include all the faculties within the University.



Foreign students coming to study in The Bucharest University of Economic Studies (ASE) Minimum standard: according to the national average for higher economic education Achieved: 688

In the reference period 688 foreign students were registered, as follows:


- 550 students enrolled in degree programs (386 licence, 118 master and 46 doctoral school),
- 71 students enrolled in preparatory Romanian language year (Faculty of International Business and Economics),
- 42 incoming Erasmus students,
- 25 students in short-term mobility (study visits at Indiana University, US, Russian Presidential Academy for Public Administration Moscow, Russian Federation and Angel Kanchev University of Rousse, Bulgaria).

Teaching and research staff beneficiary of international mobility Minimum standard: according to the national average for higher economic education Achieved: 89 visits abroad

During the reference period there were 89 visits abroad. The distribution according to the faculty of origin of the beneficiaries is shown in the following chart:





89% of trips were short-term (2-10 days), aimed at participation in international scientific activities, in international projects, missions of teaching, academic cooperation activities. The remaining 11% is represented by 3-6 weeks internship research / documentation visits.

Students beneficiaries of international mobility Minimum standard: according to the national average of higher economic education Achieved: 108 mobilities

During the reference period there were 108 student mobility within the Erasmus +: 85 mobility studies undergoing in the second semester of 2015/2016 academic mobility and 23 placement mobilities in companies / European organizations.

Distribution of student mobility within the study programs: BA - 51.8%, master - 45.4%, Ph.D. - 2.8%
