January, 2022, a new beginning:

January 13 - The Vice-Rector of International Relations, **Professor Marius Profiroiu**, had a fruitful meeting with a delegation from the **Embassy of Italy to Bucharest**, represented by Ms. Alice Rubini, First Secretary and Head of the Economic and Trade Office, and Mr. Vincenzo Tamarindo, First Secretary for Media, European, Social and Cultural Affairs. The discussions focused on various cooperation opportunities between our university and Italian universities. On this occasion, details about the upcoming visit of the Italian Minister of Economic Development at BUES were set up.



January 13 – **Info session Erasmus**+ for BUES students provided important information about study opportunities abroad, along with guidance on application requirements and registration timetable. The event that gathered around 100 students was conducted by representatives of the Erasmus+ Office, and the Erasmus Student Network (ESN).



January 21 – A **memorandum of understanding**, on academic and research collaboration, was signed between our university and **Monterrey University**, **Mexico**. The agreement was concluded in a virtual ceremony with representatives of both universities. We would like to highlight the participation of some special guests, respectively H.E. Marius Gabriel Lăzurcă, the Romanian Ambassador to Mexico, Mr. Razvan Pîrcălăbescu, the economic attaché, and Mr. Protasio Rodriguez, the embassy's proposal as honorary consul in Monterrey.



January 26 – 27 Our university hosted the second Transnational Project Meeting, **Erasmus+ TerraGov**, *Teaching Institutional Resilience and Prompt Reaction to Crisis: Good Governance Experiences in Europe*. The purpose of the meeting was to report the the midterm results, to discuss the necessary methods to improve the project's impact, and to provide updates related to the best implementation procedures. We had the great pleasure to meet the special guests of this event: Professor Aída Díaz-Tendero, Professor José M. Ruano (Complutense University of Madrid), and Professor Ivana Načinović Braje from the Faculty of Economics and Business, Zagreb, Croatia.












More news, data and information:

Doctoral and postdoctoral research grants "Eugen Ionescu" Call for applications 2022.

The "Eugen Ionescu" program allows researchers from higher education institutions that are members of AUF (Agence Universitaire de la Francophonie), to benefit from a 3-month research mobility in one of the 33 higher education institutions in Romania. The international call for applications is open until March 11, 2022. The "Eugen Ionescu" program is funded by the Romanian Government, through the Romanian Ministry of Foreign Affairs. The effective management of these scholarships is coordinated by the AUF, whose experience in these types of programs is internationally recognized.

 Regional Commissions of Economic and Scientific Experts - CREES: Call for applications for members of Central and Eastern European universities

CREES is a new regional advisory body. It collaborates with the AUF regional directorates by extension of the Scientific Council (SC), and the Economic and Social Council (ESC), which are statutory advisory bodies. SC is involved in defining the policy for the scientific evaluation of AUF programs, and the ESC approaches socio-economic, employment and entrepreneurship related issues. This call for applications exclusively refers to members from academia and science. Deadline for applications: March 18, 2022.

 Higher Education: making EU's universities ready for the future through deeper transnational cooperation

On January 18, 2022, the European Comission issued a proposal for a COUNCIL RECOMMENDATION on building bridges for effective **European** higher education **cooperation**. This Council Recommendation is part of the 'higher education package' announced in the Commission Work Programme 2022 under the headline ambition "Promoting our European way of life", together with a Commission Communication on a European strategy for universities. While the strategy sets a vision for the transformation of the higher education sector across Europe, the Recommendation is the first step of an incremental approach towards and more effective transnational deeper, more sustainable cooperation.

The Strategy and **the Recommendation** broaden opportunities for innovative transnational cooperation in the higher education sector, as working together more closely is essential for the EU to consolidate its role as a global player. Hence, there is a need to bring forces together through deeper cooperation.
