### **1st April**

Here are the auspices under which the conference "Working Romania #futureofwork" took place on April 15, the Business Review's event dedicated to human resources and the employment landscape.

Our University was represented by Prof. Constantin Marius Profiroiu, Vice-rector for international relations who was a speaker on the panel “The Future of Romania’s Labor Market – Education, Generation Z, and Competitiveness”.



Prof. Profiroiu highlighted the fact that the internationalization of higher education enhances human capital development, equipping students with global perspectives and skills that are essential for thriving in the future workforce. He has also shared his opinion on the future of work in our country stating that “the number 1 problem in Romania is related to the quality of human resources. A country that does not invest in human resources and that is not aware of what will happen in 20-30 years as a result of the lack of investments, will be an irrelevant country.”

On April 29, 2025, Professor Dr. Constantin Marius Profiroiu, BUES Vice-Rector for International Relations, met with Professor Dr. Joe Francom, Director of the Department of Computer Science at Utah Tech University, U.S.A.

## International missions

7 - 12 April

- **Eurasia Higher Education Summit- EURIE in Istanbul, Republic of Türkiye.**

Between April 7 and 12, a delegation from our university led by the Rector Prof. Nicolae Istudor and composed of Prof. Constantin Marius Profiroiu, Vice-rector for international relations, Prof. Georgiana Camelia Georgescu, Dean of the Faculty of Finance & Banking and Ms. Corina Petrea from the IRO will attend the Eurasia Higher Education Summit- EURIE in Istanbul, Republic of Türkiye.

EURIE is the annual international higher education conference and exhibition, connecting the dynamic higher education sector in the Eurasian region to the world. EURIE conference addresses current issues in internationalization of higher education and key topics in higher education management with the participation of prominent speakers and sector leaders. With numerous panels, plenary talks, roundtables and workshops, participants have the opportunity to explore trends, best practices and innovative solutions in international education.

- **Signing of the MoU with Prof. Mustafa Kurt, Rector of Marmara University.**

On this occasion a collaboration agreement was signed with the Rector of Marmara University Prof. Mustafa Kurt. During the meeting, the possibilities of collaboration between the two universities were discussed and it was agreed to initiate joint research projects as well as mutual support for participation in various European and international networks.

Marmara University is one of the oldest educational institutions in Turkey being established on 16 January, 1883 and one of the top public universities in Istanbul, being ranked #1001-1200 in QS World University Rankings 2025.

- **Study in Romania pavilion.**

We engaged in insightful sessions focused on the internationalization of higher education and connected with delegations from Turkey, India, Iraq, Malaysia, Cyprus, Palestine and Uzbekistan at the ASE stand in the Study in Romania pavilion.



- **Memorandum of Understanding with Girne American University of Cyprus.**

The participation of our University's delegation at the Eurasia Higher Education Summit in Istanbul was materialized through several bilateral meetings with partners from the region, including the signing of a new Memorandum of Understanding with Girne American University of Cyprus, on which occasion the directions of collaboration in the field of student and teacher exchanges between the two universities were established.

At the same time, the Rector, Prof. Nicolae Istudor and the Vice-rector, Prof. Constantin Marius Profiroiu participated in various panels on topical issues such as "Holistic Leadership for Better Work and Life with an Emphasis on Quantum Leadership", "Power of Transnational Education", "Behavioral AI and Assurance of Quality", "Reimagining Leadership", etc.

Prof. Georgiana Georgescu, dean of FABBV, attended also the "Women's Leadership in Higher Education" panel.

## 10th April

- **Blended Intensive Erasmus + Program "Developing Alternative Food Systems for Nürtingen, Germany.**

From April 6 - 13, a group of students from ASE Bucharest participates in the Blended Intensive Erasmus + Program "Developing Alternative Food Systems for Nürtingen", organized in Germany. The students are coordinated by professors Daniela Trașcă from the Faculty of Theoretical and Applied Economics and Simona Goia from the Faculty of Business Administration in Foreign Languages. For 10 days, the students develop business solutions for healthy and sustainable food alternatives for the residents of Nürtingen.

Coordinated by Assoc.prof. Roxana Patarlageanu, the group took part in research activities and workshops focused on agri-food economics, sustainability, and the green transition. The program encouraged international dialogue, innovative thinking, and meaningful academic exchange with peers and professionals from Serbia.

## 12th April

- **2025 EUA Annual Conference #EUA2025AC in Riga, Latvia.**

This week, the Vice-rector Prof. Dan Gabriel Dumitrescu attended the 2025 EUA Annual Conference [#EUA2025AC](#) in Riga, Latvia.

The focus of the conference this year was on [#sustainability](#) and [#resilience](#). The role of universities in reaching sustainable development is an unquestionably essential part of this collective effort that requires the involvement of society as a whole. Participants looked at sustainability (and resilience) through multiple lenses: funding, publishing, inclusion, leadership, academic careers, knowledge security, and more. Beyond this annual conference, the EUA will also continue to pay special attention to sustainability this year, by putting “Spotlight on Sustainability.” This new initiative will foster the dialogue on sustainability between universities in Europe – and beyond – and will highlight the role that universities play in achieving the SDGs.

On the margins of the EUA conference, Prof. Dumitrescu also attended the [#UNICA](#) Rectors’ Panel “Competitiveness & Inclusiveness in R&I in Europe: a UNICA perspective”, a conversation that explored the success rates of universities from Widening countries in Horizon Europe.

### Faculty of Accounting and Management

#### Information Systems

- Profesor Gabriel Donleavy (Professor of Accounting), University of New England.

**A brief description of the activity carried out:** The presentation is based on a paper that seeks to clarify the concept of accountability. It distinguishes hard accountability from soft accountability and focuses on the former. It explores the roots of accountability in ethics, the major world religions, and on the subset of biology called neuroscience. It considers what factors make accountability effectively enforced in practice. In considering that, it frames the analysis in stages three and four of the Kohlberg paradigm of ethical development. Several barriers to progressing from stage three to four are considered with particular focus on tribalism and familism. Lastly, it considers the limits of accountability, and argues that time, foreseeability, capacity and interpersonal closeness play major parts in establishing those limits.


A brief description of the activity carried out: Between March 28 and April 4, the Faculty of Marketing hosted a delegation from the University of Münster, Germany, composed of Prof. Dr. Sebastian Hohenberg, Hendrik Martin Schierwater (PhD student, Research & Teaching Associate), and master's students from the International Marketing module of their MBA program.

The visit began with a workshop entitled “SPATIAL MARKETING RESEARCH: Leveraging 3D Virtual and Interactive Spaces (3VIS) to Study Marketing Phenomena,” delivered by Prof. Dr. Sebastian Hohenberg.

Doctoral students from the Faculty of Marketing gained insights into conducting research in virtual environments, including the metaverse, 3D labs, virtual reality (VR), and augmented reality (AR).

A brief description of the activity carried out: Dr. Goharik Khachatryan, with over 20 years of experience in the fields of economics and marketing, delivered a series of lectures for students of the Faculty of Marketing, as well as for students from other faculties. These included three sessions focused on sustainable marketing and green consumer behavior, along with a lecture on sustainable consumption.

In addition, a research and academic collaboration workshop was held for faculty members and PhD students of the Faculty of Marketing. - Associate Professor Rami Aldweeri, PhD., Associate Professor of Digital Marketing, University of Jordan.



### 28-30 April 2025: Workshop Academic Writing




- Profesor Peter Claeys , Universidad Pontificia y Comillas, Spانيا.



- Researcher Babak Mehmanpazir, Dean, EM Strasbourg Business School – University of Strasbourg





- Professor Johannes Christian Fieseler, BI Norwegian Business School.


**A brief description of the activity carried out:** Dr. Christian Fieseler is a visiting professor at the Faculty of Business Administration in Foreign Languages (FABIZ), contributing to the Entrepreneurship and Technology course within the master's program Digital Business and Innovation. During his visit, he leads interactive seminar sessions featuring debates, case studies, and prototyping activities, aimed at exploring the development and optimization of digital platforms. Key topics include performance measurement, the design of fair and accessible systems, strategic planning, user experience design, and cultivating meaningful organizational culture.

**A brief description of the activity carried out:** Between April 4–6, 2025, Professor Alex Duarte delivered an intensive module within the MBA in Creative and Cultural Industries program, focusing on the theme “Identity, Branding, and Communication.” The activity began with a STORYdoing Masterclass open to the general public, which attracted 30 external participants in addition to the enrolled MBA students. This was followed by two days of interactive classes with the MBA cohort.

Professor Duarte employed case studies, hands-on exercises, and open discussions to explore brand identity development and strategic communication within the creative industries. During his visit, he also held meetings with the academic team to discuss curriculum alignment and future collaboration opportunities. All sessions were conducted as scheduled, and participant feedback was overwhelmingly positive.



### PROGRESS ON INTERNATIONAL ACCREDITATION: AACSB

The first week of April also marked important developments in our AACSB Initial Accreditation process. On April 2, the International Accreditation and Rankings Unit met online with Ms. Natalia Ilina, Accreditation Manager for EMEA, to address key aspects of ASE's AACSB accreditation journey.



Discussions focused on two strategic areas: managing newly launched and discontinued programs in the reporting framework, and the application of Standard 3 related to faculty qualification and classification — especially regarding faculty members teaching across multiple disciplines under AACSB's taxonomy. Following the discussions, final adjustments were made to the 2025 Action Plan.

The International Accreditations and Rankings Unit has completed the submission of data to the **AACSB Staff Compensation and Demographics Survey (SCDS)** via the DataDirect platform. This effort was coordinated by the International Relations Office in collaboration with the Human Resources Department.




While the SCDS reports only one full-time international faculty member, BUES actually hosted 94 international part-time professors in 2023–2024, and expects that number to grow to 105 in 2024–2025.

This data contributes to global benchmarking efforts, strengthening BUES's role within the AACSB community and highlighting its international academic ecosystem.

BUES submitted institutional data for the AACSB BSQ Programs Module Survey 2024–2025, with the support of the Education Management Service and the General Secretary of the University. This detailed and high-stakes survey captures the full landscape of business programs offered, their classification by discipline, delivery mode, and scope of accreditation.

Particularly relevant for BUES's strategic positioning is the accurate reporting of all degree programs — including those delivered in multiple languages and formats — as this data feeds directly into AACSB's myAccreditation platform and public profiles. The process required close internal coordination and rigorous validation to ensure alignment with accreditation criteria.

### INTERNATIONAL CONFERENCE

The month of April placed BUES on key international stages, where we connected with academic leaders, expanded our global network, and strengthened our voice in the global education landscape.

#### AACSB ICAM 2025 – Business Education at a Crossroads

From April 7–9, BUES was represented at the AACSB International Conference and Annual Meeting (ICAM) 2025 in Vienna by Prof. Liviu Adrian Cotfas, Director of International Relations. The event brought together over 1,200 participants from more than 60 countries, offering a dynamic platform to exchange ideas and shape the future of business education.

The agenda addressed pressing topics such as AI integration, enrollment challenges, curriculum transformation, and sustainability. Highlights included Quick Learn sessions delivering immediate, actionable takeaways, visionary keynotes, and the bold "Evolve or Expire" debate on the future of business graduates — exploring whether companies will still hire business graduates in five years.

Participants also engaged in Affinity Group Meetings — dedicated networking sessions fostering shared learning among institutions facing similar challenges. BUES also used this opportunity to share recent updates on its AACSB accreditation process during a dedicated discussion with our mentor, Assoc. Prof. Jana Péliová, Vice-Rector for Accreditation and Quality at the University of Economics in Bratislava (UEBA), during ICAM 2025.


